

## **DoD Flu Exemption Survey Report**

Collection: This survey was solicited and compiled by Captain Joshua Hoppe to collect data on the influenza vaccine religious accommodation and medical exemption process in the Department of Defense. There was a total of 143 service members who provided inputs which sampled every branch of the United States Armed Forces. All questions were optional to complete resulting in the varying numbers of responses on the charts. The responses were collected from 8 March through 1 April 2024.


<u>Summary of Results</u>: Of the 143 respondents, only 13 service members had been granted an accommodation or exemption from the flu vaccine (8 were Active Duty). Over half of the approvals (8) were medical exemptions. Of the 13 approved, 3 were approaching or had an approved retirement/separation date. There were 0 approvals in the Marine Corps, 4 in the Navy, 2 in the Army, 1 in the Air Force, 1 in the Space Force, 0 in the Coast Guard, and 5 in the Reserves, National or State Guard. Additionally, 87 service members confirmed that they had not taken the flu vaccine in previous years without having to request an exemption.


# What type of exemption did you request? 118 responses





#### What was the outcome?



<u>Conclusion</u>: The results of this survey showcase the Department of Defense has the ability to approve both Religious Accommodations and Medical Exemptions for the flu vaccine. With the exception of the Marine Corps and Coast Guard, this particular study highlights both RAs and MEs were approved. Additionally, service members had longstanding approvals (10+ years) and were still able to deploy with no issue. Finally, over half of respondents confirmed they did not receive past or current flu vaccines, nor did they suffer negative career impact from this decision.
